A properly structured corporation in Nevada offers a world of opportunity for many business owners, unmatched liability protection for officers and directors, tax savings and privacy.

FEWER TAXES.

Nevada has no income tax, no franchise tax, no inventory or gross receipts tax, and no inheritance tax on corporate shares.

UNBEATABLE LIABILITY PROTECTION.

In Nevada, liability typically stops with the corporation. As an officer or director, you normally cannot be held responsible for lawsuits against your corporation except in the case of outright fraud.

MAXIMUM PRIVACY.

Nevada does not require names of stockholders or a list of assets to be filed with the state. Nevada corporations are only required to list one officer and Nevada is the only state that allows the use of bearer shares for privacy of ownership.

ONE-PERSON CORPORATIONS.

Many states require more than one individual to create a corporation. In Nevada, one person can hold all positions in a corporation.

NO MINIMUM START-UP CAPITAL REQUIRED.

While many states require \$5,000 or more in capital to fund a corporation, Nevada has no capitalization requirements. You can form a corporation with zero dollars and stock can be issued in exchange for services.

The Five Tests You Must Not Fail

- Does your corporation have a physical business address, as well as canceled checks, to show the corporation paid for its overhead and its own expenses?
- Does your corporation have a telephone number listed in its name?
- Has a business license been issued to the corporation, if applicable?
- Does your corporation have a bank or checking account?
- Does your corporation have third party transactions?
